## Gala event

Inspired by the American Long Beach and elegant Victorian style, Breakers Beach House exudes a light, warm, and inviting atmosphere.

After being received on the beach side terrace, you will be offered a menu by chef Mitchell Hendriks, who focuses on pure, refined, and surprising dishes, with a special emphasis on seafood. During the drinks and dinner, you will be able to reconnect with old friends, and make new ones. After the desert, you are invited to the dance floor before a dedicated bus will take you back to your hotel.

## Saturday excursion

A **special excursion** is organised on Saturday 13 June. The day begins **early** (gathering at 08:30 in hotel lobby) with a 30-minute bus ride to the harbour in Muiden, from where a private boat will take you to the historic Pampus Island.

Under the guidance of an expert **tour guide**, you will explore the island's fascinating history as a UNESCO World Heritage Site, learning about its strategic role in the defence of Amsterdam and its unique fortifications.

Next, you will be taken on a private boat across the IJmeer, passing the new man-made islands that make up Amsterdam's newest district, IJburg. You will then be taken back to Amsterdam **city centre at around 14:00** for a **farewell lunch** at the Skylounge of the DoubleTree Hilton (next to Central Station). With its panoramic city views, this will be the perfect place to end the week's programme.

After lunch, you can continue exploring Amsterdam, or start preparing your return trip. Every 8 min. a train leaves from Central Station for a 30 min. ride to **Schiphol Airport**.



## Accompanying persons programme

### **Thu 11 June Kröller-Müller Museum**

On Thursday, you will embark on a cultural excursion to the Kröller-Müller Museum, beautifully situated in the heart of De Hoge Veluwe National Park. The museum is renowned for its exceptional collection of modern art, featuring masterpieces by artists such as Van Gogh, Mondrian, and Seurat, as well as its impressive sculpture garden, one of the largest in Europe.

During your visit, there will be time for a relaxed coffee break, to explore both the indoor galleries and the serene outdoor surroundings at your own pace or with a guided tour. Following the museum visit, a lunch will be served before the bus departs back to Amsterdam.



### **Fri 12 June Down-town Amsterdam**

On Friday, the day begins with a guided city walk from the congress hotel, offering a wonderful opportunity to discover Amsterdam's history, architecture, and local charm, as well as to enjoy a coffee break.

You may choose between a visit to the Rijksmuseum, home to world-famous masterpieces by Rembrandt and Vermeer, or the Stedelijk Museum, renowned for its impressive collection of modern and contemporary art. The programme concludes with a lunch at Barbounia, located in the Conservatorium Hotel.

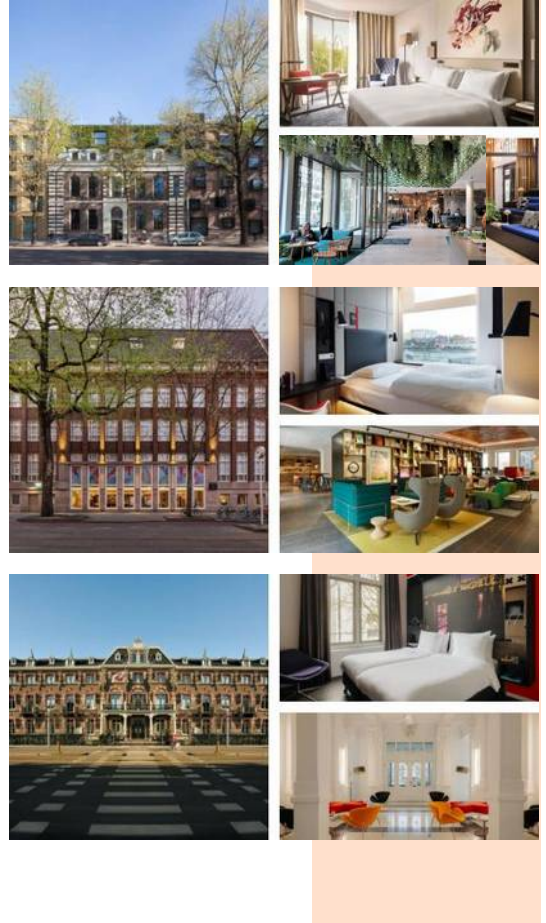
### The Manor Amsterdam
